Vaccines For Children (VFC) Eligibility

A child is eligible for the VFC Program if he or she is younger than 19 years of age and is one of the following:

- Medicaid-eligible
- Uninsured
- Underinsured
- American Indian or Alaska Native



Cost and/or Fees

There is no charge for any vaccines given by a VFC provider to eligible children. But there can be some other costs with a vaccination.



317 Adult Vaccination Program

The program provides vaccines to protect populations at higher risk that are ineligible for immunizations through the Vaccines for Children (VFC) Program and to meet urgent public health needs such as controlling vaccine preventable disease (VPD) outbreaks.



Adult Bridge Program

CDC's Bridge Access Program provides no-cost COVID-19 vaccines to adults without health insurance and adults whose insurance does not cover all COVID-19 vaccine costs.

- Provide education on the use of Naloxone



Responding to a Suspected Overdose

Naloxone Nasal Spray

This nasal spray needs no assembly and can be sprayed up one nostril by pushing the plunger.





Forms of Naloxone

Narcan - 4mg nasal spray

Kloxxado - 8mg nasal spray

ZimHi - 5mg/0.5ml injection

- 1. Distribute Naloxone
- 2. Syringe Service Program/C-HARM-ed
 - Exchange used syringes for clean ones
 - Provide bagged lunches
 - Condoms for men and women
 - Free HIV testing
 - Overdose prevention study
 - Counselors and peer support
 - Bridges for Wellness
 - Mobile Clinic



What is CMH?

Children with Medical Handicaps (CMH) Program

- ODH
- Network of quality providers
- Helps pay for approved services



Who is eligible?

- Age 0 23 years old
- Permanent resident of Ohio
- Under the care of a CMH approved provider
- Eligible diagnosis



What medical conditions are eligible?

- 1. Diagnostic Autistic Disorder
- 2. Treatment Diabetes Type I
- 3. Service Coordination Spina Bifida



Goals of CMH

- Unmet needs are determined and met
- Medical care is delivered by appropriate healthcare providers



What are the CMH programs?

- 1. Diagnostic
- 2. Treatment
- 3. Service Coordination



How is a child enrolled?

- Medical Application Form (MAF)
- Parents signed permission
- Insurance information
- Services requested by a CMH approved MD/DO/NP
- Approved Diagnosis



What is the role of the PHN?

- Have the parents received all the letters and other information?
- Do the parents have questions?
- Have they been charged out-of-pocket costs?
- What does the child need?



Other Services Available at the WCHD

- Birth and Death Records
- Creating Healthy Communities Coalition
- Emergency Preparedness
- Environmental Health Services, such as low-cost rabies clinics, inspections, and investigations
- Falls Prevention for Older Adults
- School-Based Dental Sealants
- Tobacco Prevention and Cessations
